Public Housing



The CHA's primary focus in the last year was to assess, upgrade, and reposition the public housing inventory, increase occupancy rates, increase rent collection, and increase resident access to administrative and maintenance staff.



We worked diligently on waiting list management, eligibility determinations, and admissions. The files were removed from the public housing sites and centralized at the administrative office for both the Public Housing and Housing Choice Voucher Programs. The work is assigned to one (1) Admissions and Eligibility Specialist. Historically, the CHA averages less than 50 admissions to public housing on an annual basis.

Housing Choice Voucher Program

Our Housing Choice Voucher program has consistently been a high performer for the past 20 years, earning a 96% score in 2024. The HCVP averages roughly 68 new admissions annually.

Utilization

A second-year surge of rental property sales and new investors in Chester also increased the demand for landlord access. Leasing activity has yet to return to pre-pandemic levels with a tight rental market and market gross rents often exceeding the payment standard, making it difficult for lower income households to transition to another unit. While Chester remains to be among the lowest cost rental housing in Delaware County, rents have also surged along with the rents in other areas. Due to the rise in HAP costs, CHA continues to meet its utilization goals despite the decrease in the number of households.





Entrepreneur Innovation Center



The CHA Entrepreneur Innovation Center (EIC) opened its doors in 2023, a vision brought to life by Marrea Walker Smith and her students at Devon Preparatory School. The center aims to cultivate entrepreneurial spirit and foster innovation among Chester residents. By providing training in key areas like podcasting, music production, photography, technology, digital design, and apparel design, the EIC empowers individuals with the skills necessary for financial independence. This initiative is made possible through generous grants from the McClean Contributionship and the Justamere Foundation.



Ruth Bennett Community Farm



Produce Distribution



Ruth Bennett Community Farm (RBCF) continued its mission to provide free, fresh produce boxes throughout 2024, and we're excited to receive additional funding to further support this vital program. Our bi-weekly produce distributions, which ran from May through November, culminated with a special Thanksgiving delivery. RBCF partnered once again with Philly Foodworks to pack the boxes, which contained an average of 10 different types of produce this season, along with eggs and fruit. These boxes have become an essential resource for many families and housebound seniors who rely on them as a primary source of fresh food.

In 2024, RBCF distributed 3,360 produce boxes and approximately 40,000 pounds of food, marking a 25% increase from the previous year.

Youth Crew Program

This year, our Youth Crew program saw 11 youth participants, five of whom were returning from the previous season. Over the course of the 7-week program, these youth received hands-on training in planting, watering, harvesting, and assisting with produce box distributions. In addition to this practical experience, they also participated in workshops on communication, leadership, professionalism, plant biology, herbalism, and even bouquet making.









The Orchard

The orchard is continuing to thrive. We have dozens of fruit trees and fruiting shrubs, including peaches, apricots, plums, cherries, paw paws, plums, jujubes, persimmons, figs, blueberries, raspberries, blackberries, and currants, many of which are native. An irrigation system was installed to help make sure plants receive adequate water during the growing season. The bee hives continue to thrive, and we are adding additional frames to the hives to accommodate their growth.

Ruth Bennett Community Farm



Through a grant from the USDA OPPE Socially Disadvantaged Veterans, Farmers & Ranchers Grant, RBCF staff had the opportunity to visit three farms in the South in March. They traveled to the Rockdale Farm site in Conyers, GA, run by Global Growers, Grow Dat Youth Farm in New Orleans, LA, and Eat South in Montgomery, AL. These sites were selected because of their similar scale and community-oriented programs.







In addition to this enriching trip, RBCF expanded its educational offerings in 2024 by increasing the number of workshops available to the community. Topics included Winter Orchard Pruning, Chainsaw Training, and Fungi for the Urban Gardener, among others.

We are grateful for the continued support of our community and partners as we strive to provide access to fresh, local food and meaningful educational opportunities.
